

Planning to Rent Out Your Home?

All residential rentals within the City of Sugar Land are subject to rental licensing. Unlicensed rental properties can be fined up to \$500 a day for each day the unit is rented without a license. The license must be renewed annually.

This program ensures that the owner of the rental property maintains the property and tenants are assured a rental that is up to code.

For Owners/Landlords:

- 1. Chimneystone is an HOA community, whether you are a landlord or tenant please be sure to familiarize yourself with the rules and regulations of the community before moving in or out. Landlords, it is your responsibility to ensure you and your tenants know the rules for trash and bulk waste disposal. Ultimately, you will be responsible for any violations or fines.
- Need to get rid of moving boxes? You are able to set place your cardboard into the provided recycling bin. For bulk cardboard you can request an appointment for the curbside bulk cardboard recycling service, please contact Republic Services at <u>sugarland@republicservices.com</u> or 713-726-7307. Guidelines can be found at https://www.sugarlandtx.gov/1409/Bulk-Cardboard-Recycling

3. Getting rid of bulk items?

- Bulk waste days are the 2nd Monday of each month.
- If you need bulk waste removal you can request additional bulky waste collection for a fee. Call Republic Waste at 713-726-7307 to schedule a pickup, payment must be made before they will come out. Let the HOA know if you have scheduled an additional pickup to avoid a violation notice.
- Be aware of the rules before you set anything at the curb. Toilets can be left at the curb for bulk waste pickup as long as the tank and toilet are separated.
- <u>Items left at the curb outside of normal bulk waste collection days are subject to HOA violations and fines</u> from the City as these are code violations.

Changes made to the exterior of your home must be approved by the Architectural Control Committee (ACC) to Avoid a Violation Notice and/or fine(s)

Below are some, but not limited to, the types of changes that must be approved:

- Landscaping
- Painting (Approved list of colors can be found online)
- Roofing and Gutter Replacement
- Fence Replacement
- Exterior Remodeling
- Paving (driveway replacement, extension, pathways)

Be sure you read the community rules and regulations, as well as the declarations thoroughly before you start any work and then complete an ACC form and submit for approval to cseay@cmctx.com

TOP FIVE VIOLATIONS

It can be frustrating, but knowing the top 5 violations may help you avoid a letter and/or fine for simple fixes

1. Landscaping

(*Example: Mowing, edging, weeding, tree/shrub pruning, watering, fertilizing, etc.)

2. Trash

(*Example: Leaving trash bins more than 24 hrs after collection or left where they can be seen from street, heavy trash out before scheduled day, etc.)

3. Repairs and Maintenance


(*Example: Faded or peeling paint, painted a non-approved color, faded siding, roof in disrepair, sagging or falling gutter, unapproved modifications, etc.)

4. Unsightly

(*Example: Mildew on exterior of residence or garage, sidewalks/driveway in need of power washing, weeds growing in cracks of sidewalks/driveways, faded/damaged mailboxes, etc.

5. Fence

(*Example: Old, damaged or falling, painted, non-approved fencing, etc.)

Violation Index Quick Reference

When violation notices go out there are often questions as to information regarding violations. Garbage and Recycling Collection Day:

Tuesday and Friday

On collection day, carts can be set our by 7am but no later than, 6pm the evening before. Carts **MUST** be put away no later than 8 am on the morning following the day of collection. This is not just and HOA requirement but also a city requirement. Landlords, make sure your tenants are aware.

Heavy Trash (Bulky Waste) Collection Day:

2nd Monday of Each Month

(Check City of Sugar Land Site for Schedule of Extra Collections)

On collection day, carts can be set our by 7am but no later than, 6pm the evening before. Bulky items should be set out at the curb at least four feet from other objects. Bulky waste left at curb days or weeks prior to collection will constitute a violation. You as owner/landlord are responsible for removal outside of the set collection day, no exceptions.

Green Waste Collection Day:

Tuesday

On collection day, carts can be set our by 7am but no later than, 6pm the evening before. Clear or translucent bags are required. Loose grass clippings and leaves should be placed in a reusable container. Brush and tree limbs must be less than 4 inches in diameter and less than 4 feet in length; or between 4 and 6 inches and less than 2 feet in length.
